# 1 Progress on Portfolio Matters.

## **Cromer and Mundesley**

- Celebration event, marking the completion of the Mundesley coast protection scheme held on 8<sup>th</sup> July
- Final Environment Agency Grant in Aid funding for both schemes received
- RFCC funding for the scheme is at the final assurance stage of approval; responding to questions as raised by EA.
- Cromer and Mundesley Scheme won the best "Large Infrastructure Project" Award at the Regional ICE awards ceremony.



#### **Overstrand**

- Report on dealing with the knotweed went to Cabinet on the 8<sup>th</sup> of September and all recommendations were approved. Engagement and communications now being undertaken and process are gearing up for autumn mobilisation to remove slip material, reinforce the slump and initial spray of the knotweed

- Have completed design phase for cliff stabilisation works
- Have received and are reviewing consultants' proposal for detailed design and tender documents for contractors to undertake the coast protection works.

#### Coastwise

- Coastwise Community Transition Plans: activities in communities facilitated by appointed contractors now underway
- Tenders for construction of Happisburgh Car Park relocation are currently being appraised and appointment will be made soon
- Presentations to local geography teachers on coastal adaptation and transition were well received and will assist with the development of further educational resources
- NCC Highways team are now taking forward traffic surveys to support wider work regarding future highways preparedness for erosion.

# **Repairs and Maintenance**

- Infill of cracks in Happisburgh ramp.
- Repairs to steps at East Runton following wash out.
- Repairs in Cromer to Groyne 2 and steps over groynes.

## 2 Forthcoming Activities and Developments.

## Mundesley

- In discussions with Balfour Beatty regarding arrangements for 'sweeping' of Mundesley beach to remove any remaining rock debris
- Monitoring of impacts of Mundesley stockpile, in accordance with consent conditions.

#### Overstrand

- Submission of Outline Business Case for funding for refurbishment of sea defences.
- Appointment of consultant for design of Overstrand scheme
- Preparation and then clearance of cliff material on top of the sea wall, including the licensed disposal of that containing knotweed
- Preparation for and implementation of cliff stabilisation measures
- Appointment of contractor to apply herbicidal spray on knotweed.

#### Coastwise

- Appointment of Happisburgh Car Park contractor
- Further work on the formulation of Community Transition Plans
- Appraisal and development of options relating to at-risk residential properties.
