



Register of Parish Members' Interests		Notes
<p>Name:John Powley.....</p> <p>Parish Council...Ingham.....</p> <p>These are the interests which you are required to register with the Authority by section 30 of the Localism Act 2011</p> <p>It is a breach of the Code and an offence to fail to disclose a registerable interest within 28 days of taking office with the Authority or within 28 days of declaring a new interest at a meeting.</p> <p>You must register your interests and interests of your spouse or civil partner or a person with whom you live as a spouse or civil partner.</p>		<p>(a) Please state in full the names of any organisations referred to rather than use abbreviations or acronyms.</p> <p>(b) Please, if possible, type your responses.</p> <p>(c) Where there is no interest please write "NONE".</p> <p>(d) There is no need to register "sensitive information" provided the Authority's Monitoring Officer agrees. "Sensitive information" is information which, if made public, could lead to you or a person connected to you being subjected to violence or intimidation.</p>

Employment	<p>(a) Any employment, office, trade, profession or vocation</p> <p>Motor Network and Engineering Support, Governance and Risk, Technical Repair Consultant and Subject Matter Expert. Direct Line Insurance Group</p>	<p>This includes membership of other public bodies, company directorships or trusteeships etc but only if you receive payment or other gain (including expenses) in return.</p>
Sponsors	<p>Names of people and organisations who pay or have paid or given a financial benefit towards:</p> <p>(i) my appointment with the Authority; or</p> <p>None</p> <p>(ii) The expenses I incur in carrying out my duties for the Authority:</p> <p>None</p>	<p>This does not include expenses paid by the Authority but does include payment or financial benefit from a Trade Union.</p>
