

For Disclosable Pecuniary Interests (DPI's), members are required to register not only their own interests but also those of their husband or wife, civil partner or of any person with whom they are living as if husband and wife or as civil partners when such interests are known by them. In these cases the term "relevant person" is used to mean the member and any such person.

For Other Registrable Interests (ORIs), members are only obliged to register their own interests and do not need to include the interests of husbands/wives/civil partners or others.

I have selected "None" where I have no such interests under any heading.

ORI 1- Any body of which you are a member or in a position of general management and control either to which you have been appointed or nominated by the Council, this includes outside bodies and joint committees, exercising functions of a public nature directed towards charitable purposes, or one of whose principal purposes includes the influence of public opinion or policy (including any political party or trade union). ORI 2 - The name of any person from whom you have received a gift or hospitality with an estimated value of at least £50. None
